Dear Salem Property Owner/Resident:

The City of Salem is finalizing design of a project to repair areas of eroded streambank along Goldcrest Brook. The project objective is to stabilize the channel and banks and improve habitat along portions of Goldcrest Brook. Improvements are planned within the existing easements along the creek.

The project had been tentatively scheduled for September 2024. However, due to the anticipated environmental permitting timelines as well as regulatory and logistical limitations on available construction dates, the construction is being rescheduled for July 2025.

The project areas are shown on the Project Location Map enclosed with this letter. Additional notification will be sent out as we prepare for construction. 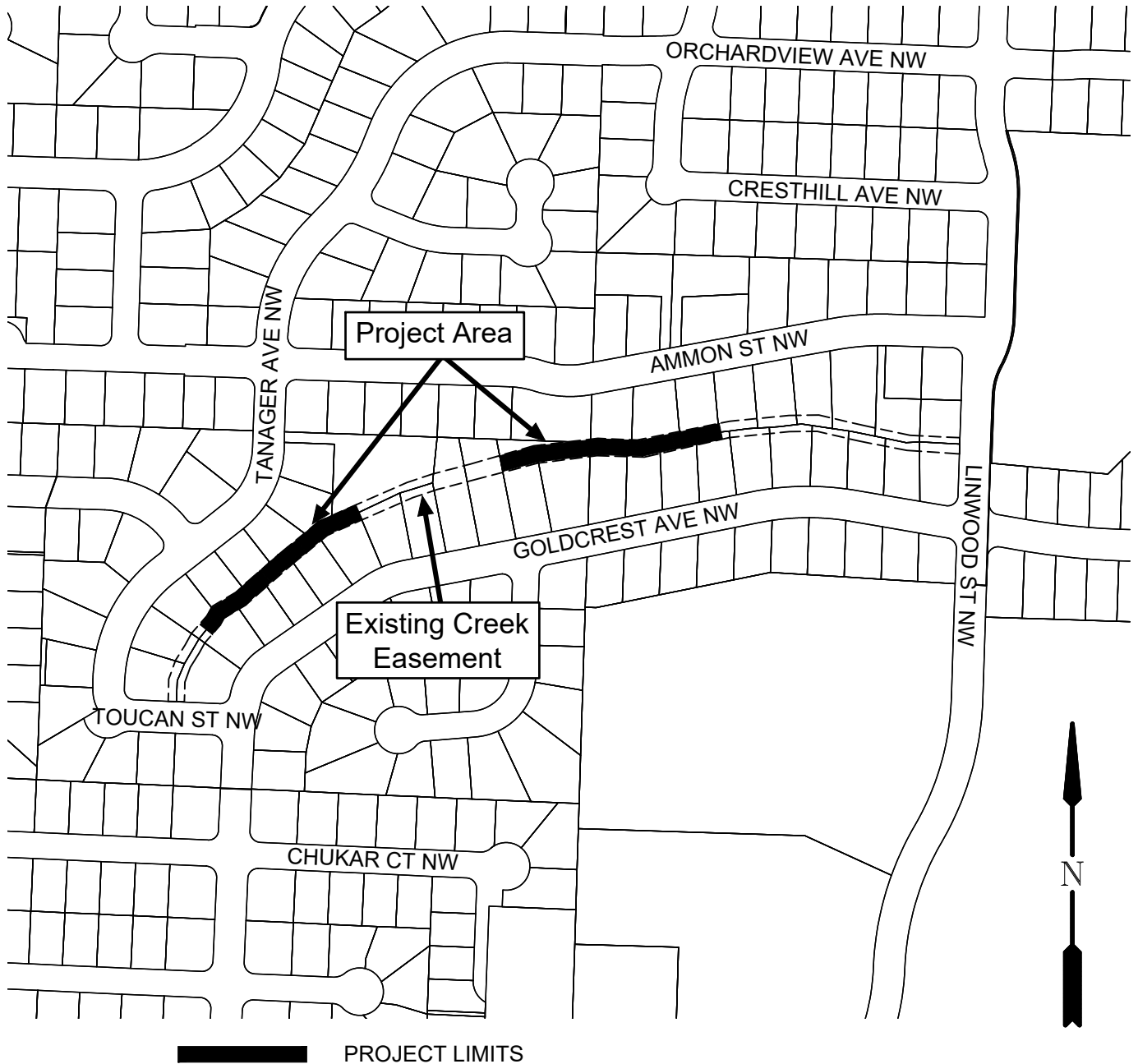
